RULES AND REGULATIONS FOR RECREATION FACILITIES

(Clubhouse, Pool, Tennis Courts, Horseshoes, Shuffleboard)

GENERAL

1. Regular hours are dawn until dusk for use by all members and guests (except for Clubhouse activities or functions).
Definition of guests: Members' houseguests and/or non-resident guests; however, non-residents are limited to two (2) per family membership. **NOTE:** Any Board Member may waive the non-resident limit on a per occurrence basis.
2. **Children under the age of 16 must be accompanied by an adult member.**
3. Member will be held accountable for any destruction of facilities and/or equipment by themselves and/or their guests.
4. The association will not be responsible for personal property loss or damage.
5. No pets allowed in Clubhouse, Pool Area, or Tennis Courts (except for service dogs). (Exceptions must be requested of the Board of Directors).
6. Members and guests are responsible for cleaning of facilities after use.
7. Persons creating a nuisance and/or showing disregard for the proper use and care of the facilities, property and equipment will not be tolerated.
8. Violations or disregard of rules and regulations are subject to review by the Board of Directors for possible disciplinary action.
9. In the event of an emergency, call 911. For any other problem call one of the Board of Directors (names and telephone numbers are posted on the bulletin board near the entrance).
10. Side pool gate will remain locked at all times. In the event of an emergency, a key is available in the pool area.
11. No skateboarding or roller-skating is allowed on parking lot or pool areas.

CLUBHOUSE

1. Admission to Clubhouse is by member number only.
2. Member numbers are issued (one per family membership) by the Membership Chairman.
3. **Members and guests** must sign in the log, names and time of arrival and departure. **THIS IS IMPORTANT.** All must sign in including guests.
4. No one under 13 years of age is allowed to play pool (billiards).
5. Those under 16 years of age must be under the supervision of an adult at all times.
6. **If you are the last person to leave the building, you are responsible for insuring that all doors are locked, and fans and lights are turned off.**
7. No bathing suits or bare feet are allowed in Main room of Clubhouse.
8. No smoking is allowed in the Clubhouse.
9. While members are allowed in the Clubhouse while other Club activities are going on, please remember that you must be quiet and not disturb the planned activity. No admittance during private rentals is allowed except for use of the swimming pool. Check calendar in the COCA News or as posted on the Rental Bulletin Board.

POOL RULES

Entrance to the pool is by pool door from inside the clubhouse only.

1. All persons using the pool or pool area do so at their own risk and sole responsibility. **NO LIFEGUARD ON DUTY**
2. No bathing suits or bare feet are allowed in Clubhouse other than in restroom area.
3. Children under 16 years of age must be accompanied by an adult at all times
4. No food or glass is allowed within the pool area. Food is allowed within the confines of the patio and picnic areas.
5. Running, jumping, pushing, wrestling, ball playing, ducking, diving, splashing, or causing undue disturbance in or about the pool area is not allowed: large inner tubes or rafts are not permitted in the pool area.
6. Appropriate swimwear must be worn in the pool.
7. No abusive or profane language or breach of peace will be tolerated.
8. All infants and toddlers using the pool must wear appropriate water-proof swimwear and be under the immediate supervision of an adult.
9. No wheeled vehicles, except wheel chairs and baby strollers, are allowed within the pool area.
10. No smoking is permitted in the pool.
11. Swimming is permitted between dawn and dusk unless otherwise posted.
12. All bathers must shower before entering the pool.
13. In the event of an emergency, call 911. For any other problem, call one of the Board of Directors (names and telephone numbers are posted on the Bulletin Board near the entrance).
14. Pool gate will remain locked at all times. In the event of an emergency, a key is available in the pool area.
15. Member will be held accountable for any destruction of facilities and/or equipment by themselves and/or their guests.

TENNIS

1. Tennis courts are for tennis only. A key is required for entrance. The key is available from the Treasurer for a \$25.00 deposit (increased to \$25.00 from \$10.00 as of 1/18/06 by vote of the Board.
2. Only tennis shoes or smooth sole type shoes are allowed. No jogging, running or basketball shoes are allowed.
3. Your attire is up to you; however, like any sport, tennis has its proper dress code.
4. Children under the age of 16 must be accompanied by an adult member.
5. Loosen nets when play is completed.
6. Make sure gate is locked when you leave.

SHUFFLEBOARD

1. All equipment must be returned to storage area in Clubhouse when play is completed.
2. No one under 13 years of age is allowed to play shuffleboard.

BOCCE BALL

1. All equipment must be returned to storage area in Clubhouse when play is completed.
2. No one under 13 years of age is allowed to play bocce ball.

NOTE: The above Rules and Regulations were adopted by the Board of Directors on April 21, 1993 and are subject to amendments and revisions as deemed necessary by the Board.
